BRIEF COURSE DESCRIPTION

The purpose of the School is to explore challenges and possible ways forward for the effective and appropriate application of the precautionary principle in sustainability governance. It will bring together a solid and diverse group of scholars and practitioners with expertise on the precautionary principle, risk assessment and management, environment and health research, science and technology studies, the governance of innovation, environmental governance, and long term transitions to sustainability.

The School is designed as a strategic knowledge and experience sharing course at the intersection between a research-oriented course and a professional development course, dedicated to collaborative exploration and learning. It will provide intensive research training, but also allow for policy discussions in a variety of sector and contexts and, through a knowledge co-creation approach, help to identify and find solutions to course-related issues in the participants' research, policy, and business application fields.

We aim to achieve a mix of participants and faculty from a variety of backgrounds (including both researchers and practitioners from public bodies, NGOs and business) and research interests related to the Course. Participants from public institutions, business, and NGOs are encouraged to apply.

The course is co-organised by Central European University (CEU), Median and the European Environment Agency (EEA). It is a pilot project of EEAcademy.

Central European University's summer school (CEU SUN), established in 1996, is a program in English for graduate students, junior or post-doctoral researchers, teachers and professionals. It offers high-level, research-oriented, interdisciplinary academic courses as well as workshops on policy issues for professional development, taught by internationally renowned scholars and policy experts (including CEU faculty). Application from all over the world is encouraged. Financial aid is available.
